## REGISTRATION FEES

Access to the Summit's proceedings, Executive Training Program (Level 1 or Level 2), the Golf Classic, the Special Session (Expand Your Toolbox) and/or the VIP Aluminio México will be granted to delegates who have signed-up, paid due fees, and who have received prior confirmation of registration.
